TANTEX can support non-profit organizations and external organizations information should only be presented via TANTEX website, e-news should only be used in text format only (hyperlink provided that will lead the supported events information to the TANTEX website). At this time TANTEX can't support any for profit, political and religious organizations. Can support national non-profit organizations with published guidelines. Support complimenting non-profit organizations. Should have TANTEX logo at the top of the banner/flyer.

		\$16,816 O Due to poor attendance ticket revenue is contributing towards only 30% of the total expenses for all major events O Outside funding is necessary to support the remaining 70% The suggestion includes \$100.00 per family for the three major TANTEX events. This model provides huge savings for the regular attendees This model provides an opportunity for those wholove TANTEX but couldn't attend due to time constraints This will be considered an "Annual Pass" (similar to EZ Pass) where there is no need to buy tickets to these three events. Majority of EC members agreed for the proposal with following inputs. The \$20.00 for annual members shouldn't be included towards \$100.00. The annual pass (Ez-Pass) amount should be \$120.00. The life members will pay \$100.00 towards annual pass (Ez-Pass). Member estimation is required. Selling tickets in advance should highly be encouraged. There should be a minimum of \$5.00 to \$10.00 difference between selling in advance vs. on the day of event (which should be higher). Need to ensure that ticket prices stay consistent, and there		
		are no levels for the annual pass (Ez-Pass). Action Item:		
		 President-Elect will draft and circulate it to the GoB. Once approved, it will be broadcasted via e-news to the members at large. 		
8	Open Items	 Radio Chair Narasimha Reddy Urimindi conveyed to the EC team that Desiplaza informed TANTEX Radio committee about the discontinuation of 1210 AM air time support from January. However Desiplaza is willing to support half of the total \$6000 expense with with some conditions. President Vijay Mohan Kakarla reminded everyone about the potential total loss of approximately \$5000 in benefits from Fun Asia since we have provided opportuynity to Desiplaza. Suresh Manduva confirmed that NATS is willing to pay \$5000.00 for the 2013 NATS convention towards TANTEX building construction. Suresh Manduva suggested that the value for Diamond sponsor (\$10,000) needs to be revaluated. Suresh Manduva as outgoing past president addressed the GoB and thanked all members and recollected his fond memories in TANTEX. President informed that consolidation of By-Laws from 2012, 2013, 2014 is important and needs to be done 2015.
