		came to Dallas, APNRT requested to distribute the flyer and it was not	
		distributed in 2017 and we request not to send current 2019 Chief	
		Minister's Visit any more and whatever we sent so far that's fine.	
		President Chinasatyam Veernapu responded to team, before approving	
		flyer to send in e-news, informed about flyer distribution request and	
		requested GoB to review the request received from North America	
		Telugu community and asked if anyone had obligation or concerns to	
		send the same flyer in eNews. Since there was no obligation or concern	
		raised from the GoB team, we sent CM flyer in eNews and also after	
		sending flyer in enews also no concerns were brought to president's	
		notice. Later few EC members raised concern that, without any official	
		request from Chief Ministers office, we aren't supposed to send the flyer	
		in our enews.

		forward how to go about communication related to Government	
		officials (Especially Chief Minister and above)	
		Summary of the GoB opinion about Government officials visit to USA (Especially	
		Chief Minister and above):	
		• Chief Minister Visit is official, we can distribute the flyer only once	
		irrespective of political party. We cannot send more than one time.	
		Any Government official representative from India visiting Dallas and	
		representing and addressing NRI's here then we should send the	
		information in the enews one time. But if the representative is coming	
		on his personal agenda and with no communication to any of the	
		GoB, we should not pass the information or promote it. Their	
		personal reason could be anything, unless it is not official, we should	
		not share the information	
		<ul> <li>Before circulating any Government official visits to Dallas in eNews, let's have a conference call and discuss.</li> </ul>	
		If we get official communication from Chief Minister's office (Indian	
		Government official/People's leader) then only send the flyer in	
		eNews.	
		• As telugu organization, we need to send communication once if any	
		government official visiting Dallas.	
		<ul> <li>If anyone see discrepancy or concern about eNews communication,</li> </ul>	
		bring it to president's notice immediately instead of waiting until GoB
